

APPLICATION CRITERIA

All candidates must:

- ✓ Have completed their second year of study
- ✓ Be currently enrolled in a bachelor or post-graduate degree majoring in property/real estate disciplines at a recognised Australian University
- ✓ Be able to work 3 days/22 hours per week

THE PROGRAM

- There are two spots available, rotating through the business over a 26 week period from May to October.
- Students are required to work 3 days/22 hours per week, with flexibility offered to accommodate study requirements.
